## TO MINIMIZE THE NUISANCE OF MOSQUITOES

1. Treat the areas where mosquitoes breed with "Larvacide".
2. Flush foilage and shrubbery with "I.F. Insecticide Fog".
3. Apply "No Host" to the turf as directed below.

**DIRECTIONS:**

**TURF AND LAWN** — To kill and aid in the control of mosquitoes and ants .... Apply one pound of granules per 1000 square feet. Apply with spreader for uniform coverage. Work granules in with a coarse water spray after treatment. Repeat two or three weeks later if necessary.

**FOR USE OUTDOORS AND AROUND THE FOLLOWING AREAS — CLUB HOUSE BUILDINGS, ROADWAYS and PATH BORDERS** — To kill and aid in the control of mosquitoes, ants, bluegrass bill bug (blue grass bill bug only in New York State) cutworm, ticks. — Apply one pound of granules for each 1000 square feet of area.

Treat at least 15 foot band around structure and extending to the foundation to discourage entry into building of ants and ticks.

Work granules into vegetative cover. Coarse water spray after treatment is desirable. Repeat two or three weeks later if necessary.
