DILUTION TRUCTIONS For contact spraying a mist spraying using Challengers, Microsols, Klip-On, and similar equipment dilute one part DILL PYRETHRIN OS SYNERGIZED CONCENTRATE with nine parts oil. For space and contact spraying with hand and pressure sprayers, dilute one part DILL PYRETHRIN OS SYNERGIZED CONCENTRATE with 19 parts oil and use as follows:

DIRECTIONS FOR USE

FLIES, MOSQUITOS, CNATS Close area to be treated, direct spray toward ceiling and fill space with mist. Keep closed for 10 to 20 minutes. Repeat treatment as necessary.

ANTS

Thoroughly spray around door frames, baseboards, win is and food storage areas. Farticular care should be taken to treat the ant trails. Repeat as necessary.

ROACHES, WATERBUGS, SILVERFISH

Spray liberally with force around refrigerators, sinks, all cabinets, around pantry she'ves, into all cracks and crevices in molding and woodwork, pipe openings in walls and floors and wherever these insects might hide. Repeat as necessary. CARPET BEETLES

Thoroughly spray infested rugs and carpets, also treat all cracks in baseboards and floor. Repeat as necessary.

CLOTHES MOTHS

Clean woolens and thoroughly spray taking particular care to treat all seams and folds. Repeat application every thirty days or store treated articles in moth tight containers. BEOBUGS

Thoroughly spray bedsteads, springs and mattresses taking particular care to treat all cracks and crevices on bedsteads, and tufts and seams on matresses. Spray baseboards, door and window casings, and wall cracks about the bedroom.

Spray liberal application to floor areas, carpets. haseboards, cracks and crevices. Also treat lower parts of furniture, animal's sleeping quarters and wherever these insects may be suspected.
