## APPLICATION:

- 1) Prior to its use, systems must be cleaned to remove algal growth, microbiological slime and other deposits. Brenco #585 should be applied at a point in the system where it will be uniformly mixed.
- 2) An initial slug addition of 5.7 to 14.25 fluid ounces of Brenco #585 per 1000 gallons of water will provide a concentration of 48 to 120 ppm of Brenco #585.
- 3) Repeat until control is achieved.
- 4) The frequency of addition depends upon the relative amount of bleedoff and the severity of the microbiological problem.
- 5) When system is under microbiological control subsequent dosage should be 6 to 14 fluid ounces of Brenco #585 per 1000 gallons of water applied every 3 days or as needed to maintain control

**NOTE:** This product weighs 8.49 pounds per gallon (at 20° C)
