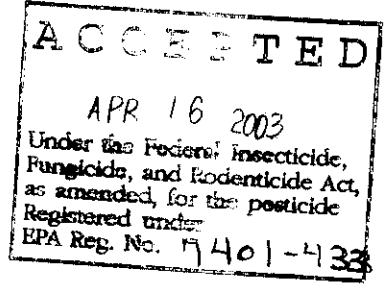

At first appearance of pests or its damage, dust lightly, directly from this container through the sifter top or apply with a hand duster. Apply to upper and lower leaf surfaces. Repeat at 7 to 10 day intervals or until pests are under control.

**STORAGE & DISPOSAL**

**STORAGE:** Store only in original container in a cool, dry place inaccessible to children and pets and away from steam pipes and radiators.

**DISPOSAL: If empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.
