Ready to use: Remove safety cap, point container toward plant, squeeze container---Shake container frequently.

Dust early morning or late evening when temperature is low and air is still. Apply to all parts, especially upper and lower leaf surfaces. Do not treat during excessively high temperatures (above 90 degrees F.) or damage may occur.

Insect control: On Roses, Dahlias, Chrysanthemums, Asters, Geraniums, Azaleas, Gladiolus, Camellias, Delphiniums, Begonias and other ornamentals for Fuller's Rose Weevil, Diabrotica Beetles, Aphids, Thrip, Red Spider, Ants, Lace Bugs, Mealy Bugs, Whitefly, Rose Leafhoppers, Omniverous Loopers and Armyworms. Treat when damage or insects first appear and at weekly intervals throughout growing season.

Disease control on Roses and other flowers: such as, Chrysanthemums and Iris for powdery mildew, leaf spot, black spot and rust: Start preventative dusting program as soon as foliage appears. Apply weekly throughout growing season.

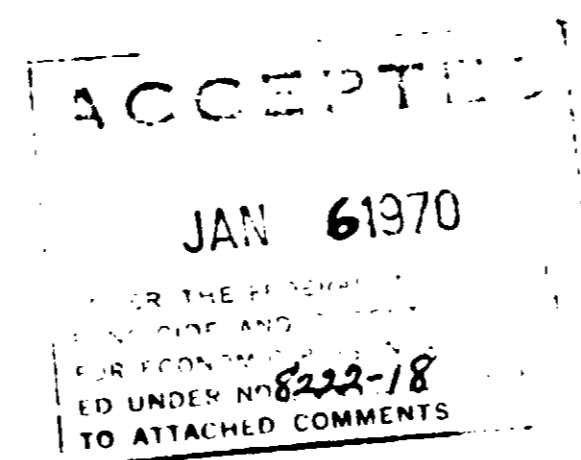
