Subject: "4 The Squirrel" Repellent
EPA Registration No. 8254-4
Your amended application of March 13, 1995

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you make the following labeling changes and submit one (1) copy of final printed labeling.

1. The proposed name change and the dropping of pigeons as claimed target species are acceptable.
2. While the proposed revised label's mentioning of two of J.T. Eaton's products is acceptable, these other products may not be sold or distributed in any package-deals with 8254-4 unless all labeling for all containers and bulletins involved has been reviewed and accepted by EPA.

This product's label may not make mention of any companion product that is to be applied over the repellent bead, nor may any general claims about such products be made, unless and until you provide efficacy data which show that applying such a product over the repellent bead does not adversely affect efficacy against target birds or increase hazards to target or nontarget species.

3. The "DIRECTIONS FOR USE" on the proposed revised label submitted on March 13, 1995, are acceptable, subject to the comments below.
 - a. Change the first sentence of the "USE RESTRICTIONS" portion of the "DIRECTIONS FOR USE" to read

"This product may be used to discourage tree squirrels (Sciurus spp. and Tamiasciurus spp.) from using treated surfaces of buildings and adjacent structures."

b. In the first paragraph of the "APPLICATION DIRECTIONS:", change "Ledges or Sills..." to, "When treating Ledges or Sills,"; and change "Roofs, Peaks, Cornices, etc...." to "For roofs, peaks, and cornices,".

c. Change the second paragraph of the "APPLICATION DIRECTIONS:" to read

"DO NOT APPLY PRODUCT IN BEADS WIDER OR DEEPER THAN THAT PRESCRIBED ABOVE. One 10.5-oz. tube of this product will treat 10 linear feet when product is applied in beads 1/2" wide and 1/2" high."

Because it is easier to count tubes than to estimate ounces of product removed from an opaque container when applied with a caulking gun, we feel that the best way to express bead length per ounce of product is in terms of the contents of one 10.5-oz. tube. We assume that there is a factual basis to the claim in this regard that appears on this product's current accepted label. Please let us know if this assumption is incorrect.

- 4. Align the word "Active" to the same left margin as the word "Inert".
- 5. Add the heading "PHYSICAL HAZARD" to the sentence "Do not apply ... if wet." Place after the "ENVIRONMENTAL HAZARD" section.

Please note that you can only sell this product with the labeling approved by the Agency.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.


USE RESTRICTIONS:

This product may be used to discourage tree squirrels from using treated surfaces. "4 THE SQUIRREL"TM is a sticky product that remains tacky at 15^oF and will not run at temperatures up to 200^oF.

PREAPPLICATION DIRECTIONS:

Select building surfaces (such as ledges, gutters, eaves, and window sills), and adjacent inanimate structures (such as signs and lamp posts), where you have seen squirrels frequently. Surface must be clean and dry to assure adhesion of repellent. Clean by wiping or scraping off all dust, dirt, loose paint, droppings, etc. On porous surfaces, such as stone or unpainted wood, surface must be sealed by applying "EATON'S"^R Porous Surface Sealant, one coat of shellac or a 50% solution of white glue.

APPLICATION DIRECTIONS:

Warm cartridge to 60^oF (16^oC) or above. After sealant coating has dried, apply repellent with a caulking gun. Properly applied bead looks like this . Ledges or Sills...apply about 1" in from edge in stripes 1/2" in diameter. Press against sill to get good adhesion and leave occasional gaps for rain water to drain. Roofs, Peaks, Cornices, etc.... apply 1/2" diameter bead along highest point. Press against surface to ensure good adhesion. Where infestation is severe, heavy squirrel traffic may flatten the bead of repellent. In these instances make a second application immediately.

DO NOT APPLY PRODUCT IN BEADS WIDER THAN PRESCRIBED ABOVE. One ounce of "4 THE SQUIRREL" WILL FORM APPROXIMATELY ONE FOOT OF BEAD.
