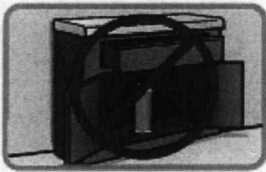

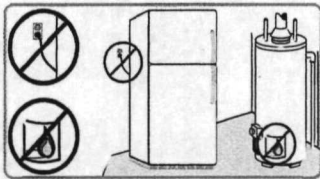

**Step 1: BEFORE YOU FOG:**

OPEN cabinets, cupboards, drawers, closets and doors in area to be treated. REMOVE or cover exposed foods, dishes, utensils, food processing equipment and surfaces. Cover waxed wood floors, waxed furniture and other plastic surfaces near the fogger (newspaper may be used). Remove pets and birds before application. Cover any water inhabited by fish (such as aquariums) during treatment and turn aquarium systems off. CLOSE outside doors and windows. SHUT OFF fans and air conditioners.



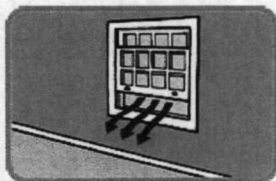

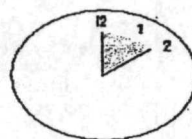
Do not place on water stainable surface. Place a chair or table in the center of area to be fogged approximately 2 ft above the floor. Cover with several layers of newspaper or paper towels. Tilt can opening AWAY from face and depress tab firmly with thumb until it clicks in locked position. Set fogger on newspaper; fill out and place door knob hang-tag on the door to the treated area and immediately leave the area.

**Step 3: AIRING OUT**

**Vacate the treated house, individual apartment unit, or other structure immediately.** Do not remain in the area during treatment. Keep treated area closed for 2 hours. **Do not re-enter for 2 hours.** Before reoccupying the area, open all doors and windows and allow to air for 2 hours.
