The resistant biotypes may dominate the weed population if these herbicides are used repeatedly in the same area. Appropriate resistance management strategies should be followed.

To delay herbicide resistance take one or more of the following steps:

- Rotate the use of this product or other Group 3 herbicides within a growing season sequence or among growing seasons with different herbicide groups that control the same weeds.
- Adopt an integrated weed-management program for herbicide use that includes scouting and uses historical information related to herbicide use, and that considers mechanical control methods, cultural, biological (weed-competitive crops or varieties) and other management practices.
- Scout after herbicide application to monitor weed populations for early signs of resistance development. DIRECTIONS FOR USE

- It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.
- This product is a selective pre-emergence herbicide that provides residual control of many grass and broadleaf weeds in established turf grasses (excluding golf course putting greens) and lawns; landscape ornamentals; and established perennials & wildflower plantings. This product controls susceptible weeds by inhibiting weed seed germination and root development. Most effective weed control will be obtained when this product is activated by at least 0.5 inch of rainfall or irrigation prior to weed seed germination and within 14 days following application.
- Not for use on plants being grown (1) for sale or other commercial use, (2) for commercial seed production, or (3) for research purposes. For use on plants intended for aesthetic purposes or climatic modification and being grown in ornamental gardens or parks, or on golf courses or lawns and grounds.
- Do not graze or feed livestock forage cut from areas treated with this product.
- Do not apply this product through any type of irrigation system.

- Do not cut treated sod before 120 days after application. Do not apply to newly set sod until the following year.
- Application of this product to turf stressed by drought, low fertility, or pest damage may result in turf injury.
- Disturbing the herbicide barrier with cultural practices such as disking may result in reduced weed control.

Apply uniformly through suitable, calibrated commercial application equipment.

ESTABLISHED TURF

This product is a selective pre-emergence herbicide that, when properly applied, will control certain grass and broadleaf weeds in established turf grass and lawns. The maximum amount of this product that may be applied per year is given for each turf grass species in the Maximum Annual Rates section of this label. Most effective weed control in turf grasses will be obtained when this product is activated by at least 0.5 inch of rainfall or irrigation prior to weed seed germination and within 14 days following application. See the information below for approximate crabgrass seed germination dates.

RATES OF APPLICATION

This product may be applied as a single application or in sequential applications to control weeds germinating throughout the year. All applications must be made prior to germination of the target weeds. This product will not control established weeds. Maximum use rate selection should be based on turf species. The length of time of residual weed control provided by this product is related to the rate applied.

APPLICATION TIMING AND INFORMATION

This product may be applied to newly transplanted and established ornamentals as a broadcast, over the top, or directed application. Irrigation or rainfall soon after application will wash residues off plant foliage and activate this product in the soil. This product may be applied at any time to established plants. Delay application to allow soil to settle around new transplants and water thoroughly before applying this product. Apply this product after cuttings form roots and become established. Apply before budding/grafting or after buds/grafts have taken to avoid any inhibition of the tissue union. This product is a pre-emergence herbicide and will not control emerged weeds. Most effective weed control in ornamentals will be obtained when this product is activated by at least 0.5 inch of rainfall or irrigation, or with shallow (1 to 2 inch) mechanical incorporation, prior to weed seed germination and within 14 days following application. Best weed control is obtained when this product is applied to soil free of clods, weeds, and debris such as leaves. Prior to application of this product, control existing vegetation by handweeding, cultivation, or the use of an appropriate post-emergence herbicide.

TOLERANT ORNAMENTAL SPECIES

This product will not harm most established ornamental trees, shrubs, and flowers. The species listed below are tolerant to this product. Best results will be obtained when this product is uniformly applied to the soil surface; avoid applying to ornamental shoots which may defeat the effort to get uniform distribution on the soil surface. This product may be applied over the top of these species without injury.
