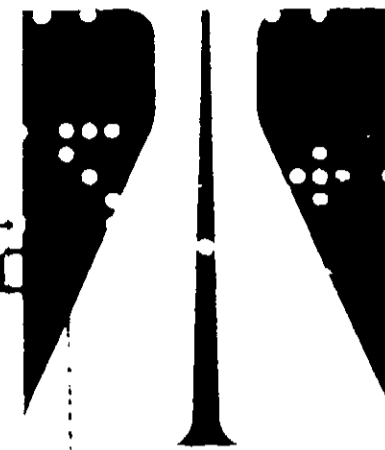
Use at the rate of 30 gals. product per 100 gals. spray, as water solution. Prepare spray mixture as directed below. Thoroughly wet foliage and stems of undesirable vegetation. The degree of control and duration of effect will vary with weed species, rainfall, temperature, and other conditions.

SPRAY PREPARATION

Water Solution — for each 100 gals of spray: Use 30 gals. product with hydraulic equipment. Fill spray tank ¼ full of water then add chemical in ratio of one gallon for each two gallons of water.
