Severe cases may require administering Vitamin K₁ intravenously and giving blood transfusions.

Stocks of existing labels may be used for eighteen (18) months. Existing stocks

Consequence If these conditions are not complied with, the registration will be subject to for noncancellation in accordance with FIFRA section 6(e). Your release for shipment of compliance the product constitutes acceptance of these conditions.


