HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive. May cause severe skin irritation or chemical burns to broken skin. Causes eye damage. May be fatal if swallowed. Avoid breathing vapors. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling this product. Wash hands after handling. Vacate poorly ventilated areas as soon as possible. Do not return until odors have dissipated.

ENVIRONMENTAL HAZARDS: This pesticide is toxic to fish, keep out of lakes, streams or ponds. Treated effluent cannot be discharged into lakes, streams, ponds or public waters unless a discharge permit is obtained. For guidance, contact the regional office of the Environmental Protection Agency.

PHYSICAL AND CHEMICAL HAZARDS - STRONG OXIDIZING AGENT: Mix only with water according to label directions. GENERAL CLASSIFICATION

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

DIRECTIONS FOR SWIMMING POOL CHLORINATION

For a new pool or for spring start-up, super-chlorinate with one (1) pint (16 fl. oz.) of sodium hypochlorite solution for each 2500 gallons of water. This dosage is equivalent to 5 ppm available chlorine by weight.

FOR POOL MAINTENANCE

A) Adjust pH of water per instructions on pH adjuster.
B) Add maintenance dose by a feeder device.
Chlorinate solution at a rate to maintain an available chlorine residual of 0.6 to 1.0 ppm. One half pint (8 fl. oz.) of sodium hypochlorite solution for each 6000 gallons of water will provide 1.0 ppm available chlorine by weight. Frequently add to maintain 0.6 to 1.0 ppm available chlorine will depend on temperature and number of swimmers. Use test kit to check pH, chlorine and chlorine residual are in the proper range.

NOTE: This product performs well when used as directed. It will increase dosage as necessary to obtain the recommended level of available chlorine.

STORAGE AND DISPOSAL: Store in a cool, dry area away from direct sunlight. In case of spill, flood area with large quantities of water. Rinse empty container thoroughly with water and either return to manufacturer and discard by placing in trash collect, or burying in an approved land fill. Product or water that cannot be used should be diluted with water and disposed of in a sanitary sewer. Do not containate from a feed or storage disposal of cleaning equipment.
