The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the Pyrethins/Piperonyl Butoxide RED, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

NOTE: This product is **not** yet being reregistered under section 4(g) of FIFRA.

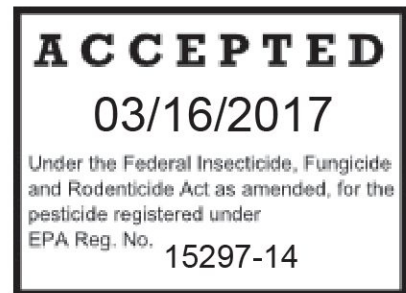

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

- Apply this product only as specified on this label.
- Do not contaminate animal feed or water during application.
- Do not allow the product to enter any drain during or after application.
- Not for use in outdoor residential misting systems.
- Do not apply to pets less than 12 weeks old. Consult a veterinarian before applying this product on medicated, debilitated, aged, pregnant or nursing animals. Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

To control fleas, ticks and lice on dogs and cats, dilute 4 ounces of concentrate with 1 gallon of water. Dip animal into solution, making sure hair is thoroughly wet to the skin. For control of ear mites, while dipping, lightly sponge inside of ears. Do not rinse. Towel dry. Repeat every 7 days if needed.

**STORAGE AND DISPOSAL**

**Pesticide Storage:** Store in a cool, dry place in an area that is inaccessible to children and animals. Store in original, sealed container away from food or feed.

**Pesticide Disposal and Container Handling:** Non-refillable container. Do not reuse or refill this container. **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
