Dear Mr. Tompkins:

Enclosed herewith are a Notification, EPA Form 8570-1, and five (5) copies of a Master Label for EPA Reg. #33034-3, submitted in response to the EPA Notice of Re-registration of March 2, 2010. The following required changes have been made:

- 1) the **Hazards to Humans and Domestic Animals** statement has been changed to read as follows: "Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse. Wear long-sleeved shirt, long pants, shoes, socks, and chemical-resistant gloves made out of any waterproof material. ";
- 2) the second paragraph under the **Precautionary Statements**, "This pesticide is toxic to fish and aquatic ... equipment washwaters or rinsate" has been deleted;
- 3) the **Environmental Hazards** section has been changed to read as follows: "This pesticide is toxic to fish and aquatic invertebrates and may contaminate water through runoff";
- 4) the restriction under **Directions for Use** has been changed to read "Do not apply this product in away that will contact adults, children, or pets either directly or through drift. Keep people and pets out of the area during application";
- 5) the use site from "backyard/homeowner ponds" to "backyard/home ponds".
- 6) the typo in the application rate from "ON TEASPOON" to "ONE TEASPOON";

- 7) the **Storage and Disposal** statements
 - a. "Open burning and dumping are prohibited" and
 - b. "Do not reuse empty container"

have been removed under Pesticide Disposal and Container Handling section;

- 8) the heading has been changed from "Pesticide Disposal" to "Pesticide Disposal and Container Handling"; and

9 the text of the "Pesticide Disposal and Container Handling section has been changed to read "Non-refillable container. Do not reuse or refill this container. **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain."

Further, the address of the place of manufacture by the registrant, United Pet Group, Inc. DBA Jungle Laboratories Corporation, has been updated to 3001 Commerce St., Blacksburg, VA 24060. The market label on the product also has an updated EPA established number to reflect this.

As a point of information, United Pet Group, Inc. DBA Jungle Laboratories Corporation is headquartered in Cincinnati, Ohio. However, the Regulatory Department which is responsible for maintaining EPA registrations as well as the manufacturing facility are located at 3001 Commerce St., Blacksburg, VA 24060.


