

**PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS
AND DOMESTIC ANIMALS**

CAUTION

Causes eye and skin irritation. Harmful if swallowed, inhaled, or absorbed through skin. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. Avoid inhaling of spray mist or dust. Do not use or store near food or feed.

During commercial exposure in seed treatment and loading operations, wear goggles, clean rubber gloves, protective clothing, and a pesticide respirator jointly approved by the Mine Safety and Health Administration (formerly the U.S. Bureau of Mines) and by the National Institute of Occupational Safety and Health under provisions of 30 CFR, part 11.

Wash hands, arms, and face thoroughly with soap and water after handling and before eating or smoking. Routinely shower or bathe after work; wash all clothing with soap and water before reusing.

Consumption of alcoholic beverages increases the toxic effect of thiram.

ENVIRONMENTAL HAZARDS

This pesticide product is toxic to fish, birds and wildlife. Do not contaminate water by cleaning of equipment or disposal of wastes. Drift or runoff from treated areas may be hazardous to aquatic organisms in neighboring areas. Do not apply directly to water or wetlands. Exposed treated seeds may be hazardous to birds and other wildlife. Dispose of all excess treated seeds by burial away from bodies of water.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.

STORAGE: Store in a cool, dry place in an area designated for pesticides, and away from food or feed. Keep pesticide in original container. Keep container firmly closed when not in use.
PESTICIDE DISPOSAL: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or sludge is a violation of Federal Law. (drum with liner) Completely empty liner by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Then dispose of liner in a sanitary landfill or by incineration if allowed by State and local authorities. Do not reuse drum. Dispose of in same manner.

(plastic) Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

This product is especially formulated for planter box or drill application. Protection is provided against seed-borne and soil-borne damping-off, and seedling blights. It contains a non-oil lubricant to assure a smooth, even flow to the furrow.

DIRECTIONS FOR USE

(Rotary Drum or Small Container) - Fill unit not more than 1/2 full. Thiram, rotate slowly until product is evenly distributed or

(Planter or Drill Box) - Place in the total amount of seed in the planter or drill box. Add remaining 1/2 of seed and Thiram and

Treat peanuts promptly after shelling. Other seeds may well cure.

Gladiolus Bulbs - Treat after drying by thoroughly coating paper bag or similar device
