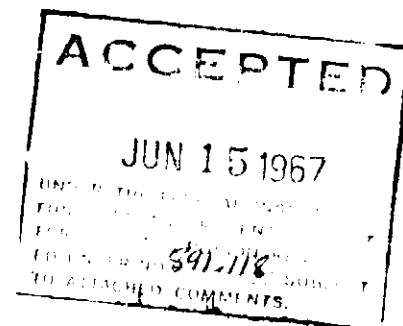

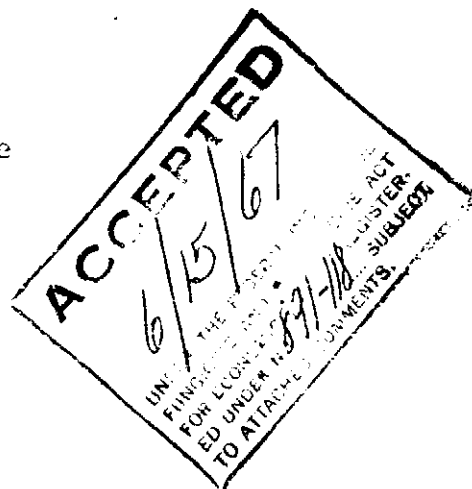

Brush-Rhap Emulsifiable Acid 2T is recommended to kill and to control the following as well as many other noxious plants susceptible to 2,4,5-T:

DIRECTIONS FOR USE

Mix the recommended amount of product with sufficient water to obtain good spray coverage.

Best results are obtained when applications are made while the plants are well leaved and actively growing.

FOR NONCROP AREAS

For control of woody plants ranging up to 6 to 8 feet in height, this product should be applied at the rate of 2 gallons mixed with 100 gallons of water. Foliage and bark should be thoroughly wet with a coarse spray. Repeat applications may be necessary if new growth appears.

DO NOT apply this product to susceptible broad-leaved plants that are desirable such as cotton, soybeans, tomatoes, grapes, clover, ornamentals. Excessive amounts of this product in the soil may temporarily inhibit seed germination and all plant growth.

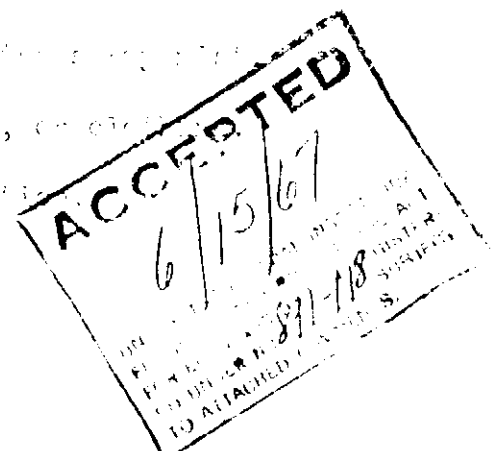
