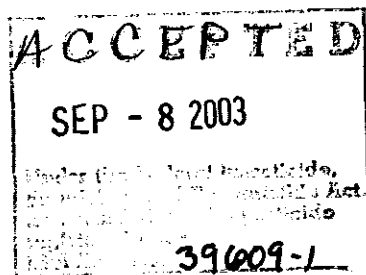

First Aid
