CAUTION

It is in violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product contains an insecticide designed especially for use in automatic dispensers. The dispenser activates the 100 mg metered valve every 15 minutes.

Usually the effectiveness of the product will be noticeable within one hour after the dispenser is activated. If less than 24 hour control is required, the dispenser should be set to start one hour before control is desired and to run one hour after control is no longer needed. Keep in mind that factors like air flow rate, room size, humidity and temperature will have an effect on insect activity and control. One unit per 6000 cubic feet is recommended as an average need. Adjustments should be made after analyzing specific conditions at the area of use. Best results of insect control are obtained when sanitation and other positive insect prevention practices are followed.
