

DIRECTIONS FOR USE
FOR USE IN HOTELS; MOTELS; HOMES:
INSTITUTIONS; PACKAGING AND PROCESSING
PLANTS; SEED HOUSES AND HORSE STABLES.

SPACE SPRAY: To kill flies, mosquitos and gnats: Close room or area to be treated. Shut off air conditioner and ventilator system. Seal all open vents. Remove fish and pets. Apply undiluted as a very fine mist space spray through manually operated equipment or with electrical and other powered applicators. Avoid staining by holding the apray nozzie at least five feet from objects. Direct the fine spray mist toward the upper corner of the room. Fill the room with a fine mist space spray at the rate of 3 fluid ounces per 5,000 cubic feet. Leave room closed for one-half hour. Ventilate thoroughly before re-entry. Sweep up and destroy insects.

CONTACT SPRAYS: To kill roaches, ants, earwigs, grain mites, sowbugs, spiders and centipedes: Adjust spray to produce large wetting type spray particles. Direct spray to contact these insects in cracks and crevices in floors, baseboards, around pipes, behind cabinets, and other harborages. Spray these infested areas until thoroughly wet. Repeat as necessary.

TO KILL SPIDERS: Spray directly on these pests and use repeated applications to the webbing and all cracks and crevices which harbor spiders.

TO KILL ANTS: Spray doors, around window frames, ant trails and fills.

TO KILL GRAIN INSECTS: Adults of confused flour beetles, sawtoothed grain beetles, shiny spider beetles: Remove infested grain cereal or flour and destroy. Avoid contamination of other food aud foodstuffs in the areas by removing before spraying. Spray directly on exposed stages and and into cracks and cravices where grain insects may be hiding. In homes, dispose of all infested products. The shelves and drawers should be cleaned and thoroughly sprayed so as to contact all pests and covered with shelf paper after allowing shelves to dry. Any utensils that are contacted with spray should be washed before using, Repeat as necessary.

PESTICIDE DISPOSAL: Pesticide, spray mixture, or rinsate that cannot be used or chemically reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies.

CONTAINER DISPOSAL: Triple rinse (or equivalent) and offer for recycling, reconditioning, or disposal in approved landfill, or bury in a safe place. A container size of 30 gais, or more may be reseated and offered for reconditioning.
