Spray-Dip Machines

Dipping Vats

Use TOXAPHENE-61 in dipping vats at the dilution given in the directions. Always stir well just before using. Water animals before dipping to prevent them from drinking dip solution. Methods used for determining the dipping vat concentration of toxaphene emulsions may be used with TOXAPHENE-61. Do not dip calves under 3 months of age.

Beef Cattle

To control Scabies, (Sarcoptic and Chorioptic Mange, Psoroptic Scab), Hornflies, Cattle Lice, Ear Tick, Lone Star Tick, Gulf Coast Tick, Winter Tick, and Cattle Fever Tick, mix 1 gallon of TOXAPHENE-61 with 150 gallons of water and stir well to form a creamy emulsion. Spray or dip animals to penetrate to the skin. Be sure not to overdose young animals. Repeat treatment for mange may be necessary and should be given in 10-14 days, if needed.

Back Rubber

As an aid in the control of Hornflies and Lice on beef cattle; dilute 1½ gallons of TOXAPHENE-61 with 34 gallons of fuel oil or other suitable carrier and fill insecticide compartment of back rubber device or soak sack or cloth as the occasion requires. Recharge device as necessary. Do not spray animals with this oil solution. Do not allow calves under 6 months of age to use rubbing devices. Do not allow beef animals to use backrubber for 30 days prior to slaughter.

Sheep and Goats

To control Psoroptic Sheep Scab, Fleece Worms and Ticks, dilute 1 gallon of TOXAPHENE-61 with 150 gallons of water and spray or dip animals thoroughly so that the solution penetrates to the skin. A second dipping may be given in 2 weeks if necessary For control of Sheep Lice, Goat Lice and Sheep Ticks (Keds) use 1 gallon of TOXAPHENE 61 with 500 gallons of water and dip animals thoroughly. When using a power sprayer, a dilution of 1 gallon of TOXAPHENE-61 to 200 gallons of water will give better results.

Hogs

To control Sarcoptic Mange and Hog Lice, dilute 1 gallon of TOXAPHENE-61 with 150 gallons of water, mix well, and spray or wash animals thoroughly. Be sure not to overdose young animals. Repeat treatment for mange may be necessary and should be given in 10-14 days, if needed. Do not treat sows within 2 weeks of farrowing or at least 3 weeks thereafter
