GENERAL CLASSIFICATION**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Swimming Pool Algicide is used to control the growth of algae in swimming pools, exterior spas, whirlpools, hot tubs, and decorative fountains. For maximum effectiveness pools, spas, whirlpools, hot tubs, and decorative fountains containing heavy growth of algae should be cleaned prior to using Swimming Pool Algicide.

For pools having just visible algae growth add an initial dose of 75 to 116 fluid ounces of Swimming Pool Algicide per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool add initially 41 to 75 fluid ounces of Swimming Pool Algicide per 10,000 gallons of water. Subsequent additions of 13.6 to 27 fluid ounces of Swimming Pool Algicide per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains having just visible algae growth require an initial dose of 8 to 12 fluid ounces of Swimming Pool Algicide per 1000 gallons of water. For treatment of a freshly cleaned and filled spa, whirlpool, hot tub, or decorative fountain, add initially 4 to 8 fluid ounces of Swimming Pool Algicide per 1,000 gallons of water. Subsequent additions of 1 to 3 fluid ounces of Swimming Pool Algicide should be made every 5 to 7 days after initial treatment for maintenance.

Swimming Pool Algicide is compatible with those chemicals normally used to treat pools, spas, and decorative fountains and is effective at both acid and alkaline pH. Swimming Pool Algicide can be used in pools, spas, and decorative fountains treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix Swimming Pool Algicide with concentrated dry or liquid chlorine products.

**STORAGE & DISPOSAL:** Keep container closed when not in use. Do not contaminate water, food, or feed by storage, disposal or cleaning of equipment. Rinsate that cannot be used or reprocessed should be disposed of in a landfill approved for pesticides or buried in a safe place away from water supplies. Open dumping is prohibited.

**METAL CONTAINERS:** Triple rinse and offer for recycling, reconditioning, or disposal in an approved landfill or bury in a safe place.

**PLASTIC CONTAINERS:** Do not reuse empty container. Triple rinse and incinerate or dispose of in an approved landfill or bury in safe place.
