### FIRST AID

## PRECAUTIONARY STATEMENTS • HAZARD TO HUMANS DANGER

**CORROSIVE:** Causes eye damage. Do not get in eyes. Wear protective clothing to avoid skin and eye contact when handling. Wash hands after handling. May be harmful or fatal if swallowed.

**ENVIRONMENTAL HAZARDS:** For aquarium use only. Remove fuzzy plants, e.g. Foxtail, and condition with lime water. After use remove dead snails, and make 1/2 water change to ensure oxygen level is back to normal.

**STORAGE AND DISPOSAL:** Do not reuse empty container. Wrap up and put in trash.

**APPLICATIONS:** Elimination of unwanted snails in freshwater aquaria. Can be used as a net bath for disinfection.

**DIRECTIONS FOR USE:** It is a violation of federal law to use this product in accordance with its labeling. Fill the DRI-PAC™ bottle 1/4 full of warm water, shake well. Fill to neck. Insert the enclosed drop dispenser in neck. Shake again. Add 1 drop per net gallon. If snails persist, dose again in two days increasing dose slowly. For net bath add 10 drops per net gallon of dipping solution desired. Soak net 5 minutes then rinse well.

This product contains 0.218 oz copper sulfate pentahydrate per 4 oz container.
