Reregistration under this section does not eliminate the need for continual reassessment of pesticides. EPA may require submission of data at any time to maintain the registration of your product.

Make the following labeling changes before you release the product for shipment:

- 1. The Child Resistant Packaging is Required.
- 2. Include the word "Poison" and the skull and crossbones symbol immediately below the signal word "DANGER" on the front panel of the label.
- 3. Under the "Environmental Hazards" statement revise the first sentence to read: "This pesticide is toxic to fish and aquatic organisms".

4. Revise the "Precautionary Statement" to read:

Fatal if inhaled. Corrosive. Causes irreversible eye damage or skin burns. May be fatal is swallowed. Do not get in eyes, on skin or on clothing. Do not breathe dust. Wear goggles or face shield. For handling activities, use dust/mist filtering respirator (MSHA/NIOSH approval number prefix TC-21C). Wear protective clothing and rubber gloves. Wash thoroughly with soap and water after handling and before eating, drinking, or using tobacco. Remove contaminated clothing and wash clothing before reuse.

5. Revise the "Statement of Practical Treatment" to read:

If Swallowed: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting.

If on Skin: Wash with plenty of soap and water. Get medical attention.

If Inhaled: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.

If in Eyes: Hold eyelids open and flush with steady, gentle stream of water for 15 minutes. Get medical attention.

- 6. The proposed label should contain a "Note to Physicians". Some suggested types of information include the following:
 - technical information on symptomatology;
 - use of supportive treatments to maintain life functions;
 - medicine that will counteract the specific physiological effects of the pesticide;
 - company telephone number to specific medical personnel who can provide specialized medical advice.

Probable mucosal damage may contraindicate the use of gastric lavage.

HOW TO USE POWER SHOCK

The pool water should be shock treated about once each week. Utilizing your pool test kil, adjust pH of pool to 7.2-7.6. Use one pound (lb.) per 6,000 gallons of water in the evening when the pool will not be used for a minimum of 12 hours. lost the chlorine residual.

NOTE: Reentry into treated swimming pool is prohibited above levels of 3 ppm of chlorine.

STORAGE AND DISPOSAL

Keep this product dry in a tightly closed container, when not in use. Store in a cool, dry, well ventilated area away from heat or open flame. In case of decomposition, isolate container (if possible) and flood area with large amounts of water to dissolve all materials before discarding this container. Do not reuse emply container but place in trash collection. Do not contaminate food or feed by storage or disposal, or cleaning of equipment.
