#### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Spa Algaecide is used to control the growth of algae in spas and hot tubs. For maximum effectiveness, spas and hot tubs containing heavy growth of algae should be cleaned prior to using Spa Algaecide.

For spas and hot tubs having just visible algae growth, add an initial dose of 4 to 6 fluid ounces of Spa Algaecide per 500 gallons of water.

For treatment of freshly cleaned and filled spa or hot tub, add initially 2 to 4 fluid ounces of Spa Algaecide per 500 gallons of water.

Subsequent additions of ½ to 1½ fluid ounces of Spa Algaecide per 500 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spa Algaecide is compatible with those chemicals normally used to treat pools and effective at both acid and alkaline pH. Spa Algaecide can be used in pools treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, do not mix Spa Algaecide with concentrated dry or liquid chlorine products.

### STORAGE AND DISPOSAL

Store in original container in a cool dry place. Do not reuse empty container. Wrap container and put in trash.
