

Precautionary Statements Hazards to Humans and Domestic Animals



DANGER-POISON

POISONOUS IF SWALLOWED

IF SWALLOWED - Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting if given anything by mouth to an unconscious person. Get medical attention.



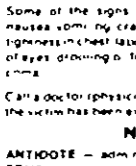
POISONOUS BY SKIN CONTACT

Poisonous if touched by hand or spilled or splashed on skin in eyes or on clothing (liquid goes through clothes).



POISONOUS IF BREATHED

Breathing vapors, spray mist or dust may be fatal.



POISONING SYMPTOMS

Parathion is a very dangerous poison. It rapidly enters the body by contact with skin, surfaces and eyes. Clothing wet with this material must be removed immediately. Exposed persons must receive prompt medical treatment or they may die.

Some of the signs and symptoms of poisoning are: headache, nausea, vomiting, cramps, weakness, blurred vision, pin-point pupils, tightness in chest, labored breathing, nervousness, sweating, watering of eyes, drooping of drooping of mouth and nose, muscle spasms and coma.

Call a doctor (physician, clinic or hospital) immediately. Explain that the victim has been exposed to parathion and describe his condition.

NOTE TO PHYSICIAN

ANTIDOTE - Administer atropine sulfate in large doses. TWO TO FOUR mg. intravenously or intramuscularly at 5 min. intervals is overcome. Repeat at 3 to 10 minute intervals until signs of atropine from appear. 2 PAM chloride is also an antidote and may be administered in conjunction with atropine. **DO NOT GIVE MORPHINE OR TRANQUILIZERS.** Parathion is a strong cholinesterase inhibitor affecting the central and peripheral nervous systems and producing cardiac and respiratory depression. At first sign of pulmonary edema, the patient should be given supplemental oxygen and treated symptomatically. Continued absorption of the poison may occur and fatal relapses have been reported after initial improvement. **VERY CLOSE SUPERVISION OF THE PATIENT IS INDICATED FOR AT LEAST 48 HOURS.** Treat symptomatically.

USE ONLY WHEN WEARING THE FOLLOWING PROTECTIVE EQUIPMENT AND CLOTHING

Protective clothing and respirators are required for all applicators and other personnel involved in mixing and transferring or otherwise handling this pesticide. Protective clothing must consist of long-sleeved shirt, trousers or synthetic rubber boots or boot covers, long-sleeved shirt and long pants. Full face respirators are recommended, full face respirators are required. As partly approved by the Mining, Health and Safety Administration (formerly the U.S. Bureau of Mines) and by the National Institute for Occupational Safety and Health under the Provisions of 30 CFR Part 11.

Wash protective clothing and protective equipment with soap and water after each use. Respirator should be cleaned and filter replaced according to instructions included with respirator.

Environmental Hazards

This product is toxic to fish, birds and other wildlife in treated areas. Do not spray over lakes, streams, ponds, tidal marshes and estuaries. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from treated areas. Do not contaminate water by cleaning of equipment or disposal of wastes. MIXING AND SPRAYING

Add the concentrate to the spray tank while filling with water, and mix thoroughly either by means of a tank agitator or pump by pass. For best results, thoroughly cover all surfaces to be treated with spray.

The following dosage rates are to be used in sufficient water to cover the specified area. For application by air, add the desired amount of concentrate per acre to 1 to 3 gallons of water. For application by ground equipment add the desired amount of concentrate per acre to 3 to 10 gallons of water.

Storage and Disposal

Do not contaminate water, feed or feed by storage or disposal. Do not dump in trenches.

Portable Disposal: Pesticide spray mixture or clean water that cannot be used according to label instructions must be disposed of according to Federal or approved state procedures under Subpart C of the Resource Conservation and Recovery Act.

Container Disposal: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other approved state and local procedure.

For control of army worms, cutworms or grasshoppers. Use 1 to 1 1/4 Quarts per acre of this material in sufficient water to give good coverage.

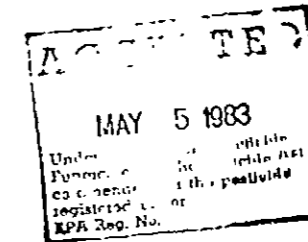
