For Use in Manufacturing and Formulation Only: **ORIENTAL MOTH TECHNICAL PHEROMONE** is to be used only for formulation into end use products (e.g., pheromone dispensers) used for the control of infestation and damage caused by the oriental fruit moth (*Grapholita molesta*), Macadamia Nut Borer (*Cryptophlebia ombrodelta*) and Koa Seed Worm (*Cryptophlebia illepidia*). This manufacturing product is not for the direct treatment of pests. Do not use from damaged, punctured, or unsealed containers. End-use products formulated from this product must be registered by the US EPA. This product may be used to formulate products for additional uses not listed on this label if the formulator, user group, or grower has complied with US EPA data submission requirements regarding the support of such uses.

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**PESTICIDE STORAGE:** Store below 40°C in a dry location until used.

**NON-REFILLABLE CONTAINER:** Do not reuse or refill this container.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**CONTAINER HANDLING:** For containers weighing under 50 lb: Clean container promptly after emptying. Triple rinse container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Offer for recycling if available or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

For containers weighing over 50 lb: Clean container promptly after emptying. Triple rinse container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Offer for recycling if available or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
