STATEMENTS OF PRACTICAL TREATMENT

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed. Wash thoroughly after handling and before eating or smoking. Do not contaminate food or cooking utensils. Keep children & pets off treated areas until dry & area has been vacuumed. Contains Sodium Lauryl Sulfate, an eye irritant. Avoid contact with eyes.

ENVIRONMENTAL HAZARDS

Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as directed on this label.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **STORAGE:** Store product in its original container in a cool, dry, locked place out of reach of children. **DISPOSAL:** Do not re-use empty container. Wrap and put in trash. Wrap vacuum bag in the same manner and also put in trash.

It is a violation of Federal law to use this product in manner inconsistent with its labeling.

WHEN TO USE

Use BLUE LUSTRE CARPET SHAMPOO WITH FLEA KILLER when pets have caused the presence of Fleas. To prevent a possible second generation from Flea eggs in the carpet wait 7 days and apply BLUE LUSTRE FLEA KILLER FOR CARPETS, a powder. Used as directed BLUE LUSTRE is safe for all fabrics that won't shrink or fade.

*NOTE: DO NOT USE THIS PRODUCT IN "STEAM" or "HOT WATER" EXTRACTION CARPET CLEANING MACHINES. These machines destroy the Flea killing power by removing the shampoo/insecticide from the carpet before it can effectively kill the fleas.

PREPARE THE AREA

Before treatment, thoroughly vacuum. Test fabric for colorfastness. Remove furniture & pets from area.

HOW TO MIX

Shake thoroughly. Add 1 part BLUE LUSTRE FLEA SHAMPOO FOR CARPETS to 7 parts cool water. Mix slowly to avoid foaming.

HOW TO USE

Apply the "foam" to carpet by starting at the farthest end of room and working backwards to the door or exit. Move the shampooer back and forth in 3 ft. x 3 ft. areas. Overlap for even cleaning. Don't soak. While still damp, stroke carpet nap with a broom or brush for even appearance. Leave the shampoo-foam residue on the carpet until it has dried; approximately 2 to 4 hours. Use a fan or ventilation for quicker drying. Vacuum thoroughly. Keep children & pets off treated area until it is dry & has been vacuumed. Use a new vacuum cleaner bag. Thoroughly rinse the shampooer tank.
