### DIRECTIONS

COTTONSEED: Thrips, Cotton Aphids, Black (Greasy) Cutworm - Use entire package at a rate of 8 oz. per 100 lbs. seed in enough water to give adequate coverage of the seed. ORTHENE 80 WSP Seed Protectant can be applied as a separate treatment or can be mixed in the slurry tank with most of the fungicide seed treaters in common use.

This bag contains one multiple water soluble packet (s) of ORTHENE 80 WSP Seed Protectant. Open outer bag by pulling perforated tearstrip.
