Dear April Mihalik:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Inorganic Halides Amended Interim Registration Review Decision, and has concluded that your submission is acceptable.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. Pursuant to 40 CFR 156.10(a)(6) you must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised

labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. See FIFRA section 2(p)(2). If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process, FIFRA section 12(a)(1)(B). Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6. **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. This product is not for use in outdoor pools.

To remove visible yellow or mustard algae: (All dosages are for 10,000 gallons of water).

1. Brush walls and floor areas affected by yellow algae accumulations.
2. Apply 4 oz. of *The Yellow Stuff* per 10,000 gallons as close to the affected areas as possible. For severe accumulations, double the above dosage.
3. Super-chlorinate by following directions of that product's label.

Swimming may be resumed a few hours after treatment, or the bromine level is below 4ppm as measured by a bromine test kit.

**WEEKLY MAINTENANCE TREATMENT**

To prevent accumulation of yellow algae: (All dosages are for 10,000 gallons of water).

1. With water temperature over 80°F, add 4 oz. of *The Yellow Stuff* with one gallon liquid chlorine or one pound of a dry chlorine once a week.
2. With water temperature under 80°F, add 2 oz. of *The Yellow Stuff* weekly and 1/2 gallon liquid chlorine or 1/2 pound of a dry chlorine.

**DISCHARGE DIRECTIONS FOR COMMERCIAL AND RESIDENTIAL POOL USES**

Before draining a treated pool, contact your local sanitary sewer and storm drain authorities and follow their discharge instructions. Do not discharge treated pool water to any location that flows to a gutter, storm drain or natural water body unless discharge is allowed by state and local authorities.

**STORAGE AND DISPOSAL**

Keep product dry in tightly closed container when not in use. Store in a cool, dry, well-ventilated area, that is inaccessible to small children, away from heat or open flame.

**PESTICIDE DISPOSAL:** To avoid waste, use all material in this container according to label directions.

**CONTAINER DISPOSAL:** Non-refillable container. Do not reuse or refill this container. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinse into application equipment or a mix tank or store rinse for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. If recycle is not available, securely wrap container in several layers of clean newspaper and discard in trash.
