The amended labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable.

The alternate brand name KurVantage Water Dispersible Granules has been added to the registration, and our records have been updated accordingly. This approval does not affect any terms or conditions that were previously imposed on this registration. You continue to be subject to existing terms or conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one (1) copy of the final printed labeling before you release this product for shipment with the new labeling. In accordance with 40 CFR § 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR § 152.3.

#### **DIRECTIONS FOR USE**

It is a violation of Federal law to apply this product in a manner inconsistent with its labeling. Do not apply this product in a way that will contact workers or other persons, either directly or thorough drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the State of Tribal agency responsible for pesticide regulation.

### **Agricultural Use Requirements**

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This standard contains requirements for the protection of agricultural workers on farms, forests, nurseries and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry intervals (REI). The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas during the restricted-entry interval (REI) of 4 hours.

PPE required for early entry to treated areas that is permitted under the Worker Protection Standard and that involves contact with anything that has been treated, such as plants, soil or water, is: coveralls, waterproof gloves, protective evewear and shoes plus socks.

Avoiding spray drift at the application site is the responsibility of the applicator. The interaction of many equipmentand weather-related factors determines the potential for spray drift. The applicator and the grower are responsible for considering all of these factors when making decisions.

BMP 123 (2X WP) is a microbial larvicide for use against the listed lepidopterous insects. Close scouting and early attention to insect infestations are recommended. BMP 123 (2X WP) must be ingested to be effective. For effective treatment, follow the directions below:

- 1. Larvae must be actively feeding on exposed plant parts.
- 2. Applications must be made when larvae are in early instars before extensive crop damage occurs. For the control of mixed insect populations or overlapping generations, use BMP 123 (2X WP) in combination with another approved insecticide.
- 3. Thorough spray coverage with BMP 123 (2X WP) is required for consistent control. Spray nozzles and volume applied will vary depending on crop and pest. Under heavy pressure, higher rates, increased gallonage, and shorter spray intervals will improve crop coverage and pest control.
- 4. Repeat applications at 3-14 day intervals to maintain control. This will depend on weather, plant growth rate, and insect activity.
- 5. In applications on hard to wet crops such as cole crops, addition of a spreader sticker approved for use on growing and harvested crops will improve coverage and weathering properties.
- 6. Unless otherwise indicated, use at least two (2) gallons of water per acre except in California where five (5) to ten (10) gallons of water are typically used.
- 7. Apply BMP 123 (2X WP) as a pre-harvest treatment to raw agricultural commodities.
- 8. Do not apply this product through any kind of irrigation system.

Apply BMP 123 (2X WP) in conventional aerial or ground equipment with sufficient water to provide thorough coverage. Add an approved spreader/sticker to the mix tank after BMP 123 (2X WP) has been mixed with the appropriate amount of water.
