This process additive product is effective in controlling microorganisms such as bacteria, lunci and yeasts which cause deterioration of linished paper and paperboard products or articles molded from paper pulp. If the product is used as a beater additive, the degree of retention of the active incredent will depend upon the nature of the other adritions in the system.
