The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1) Please submit or cite efficacy data for the following marketing phrases: "Keeps Outdoor Areas Bug Free for Hours", "Provides a Bug Free Outdoor Area for Hours", "Kills for 24 hours", "Keeps Killing as Insects Land on Treated Surfaces", "Kills Crawling Insects", "Kills Scorpions", and for the following pests: scorpions, mosquitoes, and cockroaches. We could not find any efficacy data in your file or in the file of the product you originally cited when you registered this product. If you can not submit or cite any data for these marketing phrases/pests please remove them from your label.
- 2) Either delete all "Repeat as necessary" - type statements from your label or qualify by stating the minimum allowable time interval between applications. This should be based on the efficacy data cited in support of your product and the duration claims currently claimed.

When sprayed on surfaces outdoors, Bengal Yard and Patio Outdoor Fogger residually kills flying insects that land on treated surfaces for 24 hours.

## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

## OUTDOOR PESTS

**FLYING INSECTS:** To kill flies, mosquitoes, sand flies, gnats, small flying moths:

**Space Treatment:** Direct fog so that it drifts over the area to be treated. Spray towards bushes, trees and ornamentals from at least 4 to 6 feet away. Give special attention to breeding sites such as garbage cans and compost piles. Do not allow drift over ornamental fish pond pools. Cover if possible before treatment. For spaces such as screened-in porches, spray at the rate of 10 grams (3 seconds) per 1000 cubic feet of space. If possible, keep area closed for at least 30 minutes after spraying. Do not remain in treated area and ventilate before re-entry.

**Surface Treatment:** For residual control of flying insects treat screens, around window and door frames, porches, surfaces around light fixtures, ornamental bushes, in garages and other surfaces where flying insects light or gather. Hold can 2 to 3 feet from the surface to be treated and spray to slightly moisten the surface. Bengal Yard and Patio Outdoor Fogger will not damage plants and bushes or finished surfaces on homes or buildings. Repeat as necessary.

## CRAWLING INSECTS:

To kill cockroaches, ants, spiders, crickets, scorpions, sowbugs, centipedes: Contact as many insects as possible with the spray. For residual control of crawling insects on outdoor surfaces, spray where pests are active or where they may enter buildings. Special attention should be paid to cracks and crevices, window and door frames, eaves, porches, patios and garages. Hold can 2 to 3 feet from the surface to be treated and spray to slightly moisten surface. **SPIDERS:** treat surfaces where spider webs are seen to kill spiders and prevent other spiders from building webs for up to 30 days. Direct exposure to rainfall reduces this products effectiveness. Repeat as necessary.

## PRECAUTIONARY STATEMENTS

### HAZARD TO HUMANS AND DOMESTIC ANIMALS
