

CARPETS: Apply to dry carpet only. Apply directly to all carpeted areas and where pets frequently traffic or sleep at the rate of one pound per 500 square feet (6.3 mg/sq. in.). Work product to the base of the carpet pile with a broom or rug rake.

Visible product remaining after application must be removed by further grooming or by vacuuming.

Allow three to five weeks for maximum flex control. Reapply as necessary.

Note: If a high adult population makes it desirable, apply a pesticide designed to kill adult fleasbefore or in conjunction with this product.
