Usage Information:

BABOLNA RESIDUAL FLEA KILLER AEROSOL contains an Insect Growth Regulator (IGR), and insecticide combination for indoor control of fleas and ticks, ensuring six-months residual effect. The aerosol gives protection against both adult and larva fleas. Methoprene, the (IGR), works specifically on pre-adult fleas, preventing them from maturing into biting adults. Pyrethrins and Permethrin, which efficacy is enhanced by the synergist, kill adult ticks, fleas and other insects very quickly and effectively. BABOLNA RESIDUAL FLEA KILLER AEROSOL is especially

developed for surface treatment. **Do not use this product directly on domestic/companion animals (dogs, cats, puppies, or kittens).**

Application Directions:

Thoroughly vacuum before spraying. A test application should be made to upholstery or drapery fabrics in an inconspicuous place before use. Shake well before using.

A noticeable foam will appear during application; this foam helps provide a uniform spray pattern and will dissolve a few minutes after application.

For Flea and Tick Infestations: [One 24.7 oz. (700 gm) can treats up to 3000 square feet of surface area. One 17.6 oz. (498 gm) can treats up to 2,134 square feet of surface area.] Hold can upside down, point application tip toward surface to be treated and push button to activate. Apply in a sweeping motion 2-3 feet from the surface area being treated. Apply spray in a uniform pattern to all surfaces infested with fleas and ticks including carpets, rugs, drapery, furniture, and around pet sleeping/resting areas (pets not present). Lightly dampen, but do not saturate, treated surfaces. Thorough coverage provides the best results for flea and tick infestations. Do not remain in treated area. Exit area immediately and remain outside the treated area at least 15 minutes or until spray has dried and aerosols, vapors, and mists have dispersed. Reapply as reinfestation warrants, within 14-21 days, especially to infested areas possibly missed in the original treatment.

Simultaneously treat pets with a flea and tick control product registered for use on pets prior to allowing reentry into treated areas.

Storage and Disposal
