SUBJECT: Label Amendment for Product Transferred from
Pace International, LP
NuLife Lawn Winterizer 5-3-8,
EPA Reg. No. 64864-19
Application Dated September 11, 1998

The labeling referred to above, submitted in accordance with registration under the Federal Insecticide, Fungicide, and Rodenticide act, as amended is acceptable with the following provisions:

1. Under the "Precautionary Statements" revise to read as follows: "Causes moderate eye irritation. Harmful if swallowed, inhaled, or absorbed through skin. Avoid breathing dust or contact with eyes, skin and clothing. Wash thoroughly with soap and water after handling."
2. Under the "Statement of Practical Treatment" section of the labeling, revise as follows:
 - a. In the "Ocular Statement" delete the phrase "for at least 15 minutes" so that it reads: "Flush eyes with plenty of water."
 - b. In the "Dermal Statement" add the following sentence: "Get medical attention if irritation persists."
3. On the first page of the labeling, delete the phrase "Helps control disease", and on the second page, second paragraph, delete the phrase "disease resistant" because the claims imply that the product may contain a fungicide for disease control or a plant regulator to induce disease resistance. In addition, on the first page of the labeling, delete the phrase "natural organic" as this claim constitutes an implied safety claim."

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

To take lawns through the Winter season in a sturdy, disease resistant condition, use NuLife Fall Winterizer Moss Cure & Lawn Food during the fall, anytime after September 1.

The most satisfactory results from application of this product are obtained if the following steps are taken (preferably in this order):

1. Rake lawn with a steel rake, scratching up trailing moss and grass mat. Mow to 1" height.
2. Apply this product with a fertilizer spreader, using 40 lbs. per 5,000 sq. ft. of lawn area.
3. Water thoroughly to wash (distribute) this product (fertilizer) into root zone after application.

spring, summer, autumn	1 Evergreen Multi-Purpose Top Soil: Create a growing medium for lawns, gardens, or wherever the ground is of a hard, clay consistency.
autumn, winter	2 Evergreen Fall & Winter Lawn Food & Moss Cure 8-8-8: For building of strong roots and ridding moss from lawns.
spring, summer, autumn	3 Evergreen Garden Fertilizer 5-10-10: Mix into soil and at regular intervals for lush, green plants.
