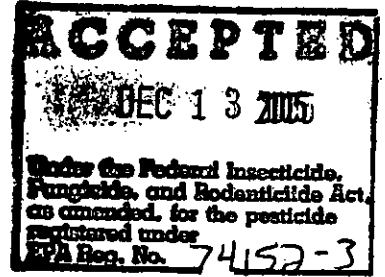

DIRECTION FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

GENERAL USE: Spray as a fine mist at 14 day intervals during growing season. Spray until solution runs from leaf surface.

OUTDOOR/INDOOR FLOWERING SHRUBS, ORNAMENTAL PLANTS: Spray as a fine mist at 14 day intervals during growing season. Spray until solution runs from leaf surface. (DO NOT USE ON FERNS)

LEAFY VEGETABLES, MELONS, PUMPKINS, SQUASH, TOMATOES, PEPPERS, CABBAGE, BROCCOLI, CAULIFLOWER, STRAWBERRIES: Spray as a fine mist at 14 day intervals during growing season. Spray until solution runs from leaf surface. For peppers, tomatoes and strawberries apply 7 days after planting. For leafy vegetables, cabbage, broccoli, and cauliflower apply at 2-3 inch stage. For melons, pumpkins, squash apply at bunching.

CITRUS: Spray as a fine mist at 14 day intervals during growing season. Cease application 2 weeks prior to harvest.

GRAPES, BLUEBERRIES: Spray as a fine mist as fruit begins to form.

COMPATIBILITY: Product is generally compatible with pesticides and fertilizers used commonly in vegetable and fruit growing. Do not mix this product with lime or other highly alkaline materials. If mixing this product with other products, this product should always be the last ingredient added to the mixture.

STORAGE AND DISPOSAL: **Pesticide storage:** Store in original container away from extremes of temperature, excessive moisture and humidity. Avoid storage near oxidizers, strong acids or strong alkalis. Do not use copper, zinc, tin, or their alloys in storage or handling systems for this product. **Container disposal:** *If empty:* Do not reuse bottle. Place in trash or offer for recycling if available. *If empty:* Do not reuse this container. *If partially filled:* Call your local solid waste agency for disposal instructions.
