

TERM-A-RID 613® BORATE TREATED WOOD CHIPS

The purpose of Term-A-Rid 613® Borate Infused Wood Chips is to reduce the population of worker termites (termites without wings), by feeding on the mulch next to a structure. Feeding on the mulch may kill worker termites and this may reduce the termite population in the area covered with the mulch. Use of this product does not substitute for mechanical alteration soil treatment or foundation treatment, but is merely a supplement to a termite monitoring and control program.

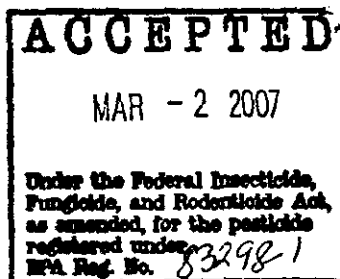

FIRST AID

GENERAL INFORMATION

Term-A-Rid 613® is a wood product containing a 0.5% Borate salt. The Term-A-Rid 613® will not degrade as rapidly as untreated wood chips.

Term-A-Rid 613® is not a replacement for routine termite inspection and treatments when activity is discovered.

APPLICATION

Apply the wood chips as mulch along the line foundation to a distance of three feet from the wood structure, including garages, tool sheds, pump houses, stables and homes. Apply at a rate of 2 to 3 inch minimum depth.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Store in a cool, dry place inaccessible to children and pets.

Disposal: *If empty:* Do not reuse this container. Place trash or offer for recycling if available.

If partly filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
