DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

TO KILL CLOTHES MOTHS

Use Restrictions: For control of eggs, larvae, and adults of clothes moths in clean, air-tight containers (e.g., chests and trunks) and garment bags. Do not use in containers, dry cleaning, and garbage bags that allow vapors to escape into occupied rooms. Do not use this naphthalene-containing product with any other moth control chemical. As this product can damage some plastics, use only in polyethylene or polypropylene containers.

Pre-Application Directions: Before storing, dry clean, wash or brush articles to be protected.

Application Directions: Apply product only in clean, air-tight containers and bags listed above at the following rates:
