The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

Leave birds in cage. Remove food and foodstuffs. Spray directly on birds from a distance of 12 to 18 inches. Avoid the bird's eyes and face. Spray lightly in 3 to 4 bursts. For cage mite control, remove bird(s), food, and water cups, etc. and spray cage thoroughly by holding unit at least one foot from surface utilizing 5 to 6 bursts. To control mites and bird lice, repeat treatment on bird or on cage no more than 2 times a week. Bird cages should be cleaned in hot water as part of a weekly regimen.

STORAGE AND DISPOSAL

Pesticide Storage: Store in a cool, dry place away from heat, open flame, water supply and food supplies that is inaccessible to children and pets. **Pesticide Disposal and Container Handling:** Non-refillable container.
