### Dear Ms. Rothwell:

The amended label and CSF(s) referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, are acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved label and bait station model (MD1/MD1a) for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product with the revised bait station model (MD1c) and with either this revised labeling, or with subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Please note that the record for this product currently contains the following CSF(s):



If additional units are to be used, place bait at 8- to 12-foot intervals. [Stations can be used horizontally or vertically.] Maintain an uninterrupted supply of fresh bait for at least 15 days or until there no longer are fresh signs of house mouse activity in infested areas. To monitor for replacement, view bait via see-through lid. While wearing gloves, remove bait station if bait has been consumed or contaminated. Replace station with a new one if house mouse activity continues at that location. Note: Mice will eat a small amount of bait and leave the station.
