



APPLICATION DIRECTIONS:

Place the [TC RAT KILLER 122] bait station [horizontally or vertically] at point of highest activity beside burrows, along a wall or in corners where signs of rats or house mice have been seen. [Stations can be used horizontally or vertically.] If additional units are purchased, place bait stations at 15- to 30- foot intervals. Maintain a constant supply of fresh bait for 10 days or until there no longer are fresh signs of rat or house mouse activity in infested areas. Replace bait stations if bait is consumed or contaminated.
