The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.



"To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

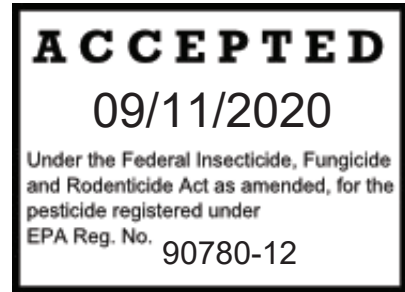

For control only of Norway rats, roof rats, and house mice. This bait station can only be refilled with the block bait sold with this station. TC Rat Killer- Rock Bait Station [This product] must be used in and around buildings consistent with all use restrictions and other requirements indicated on this label. Do not place this bait station or stored block bait in any area where there is a possibility of contaminating food or surfaces that come into direct contact with food. Store bait block refills out of reach of children and pets.

SELECTION OF TREATMENT AREAS: Determine areas where rats and/or house mice will most likely find and consume the bait. Generally, these areas are beside burrows, along outdoor walls, by gnawed openings, in corners and concealed places.

APPLICATION DIRECTIONS:

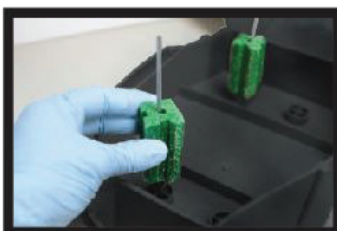

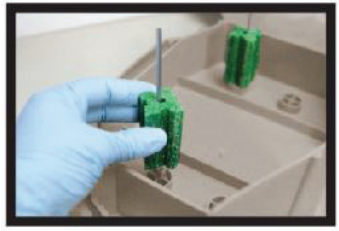
