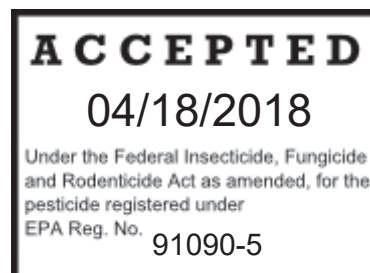

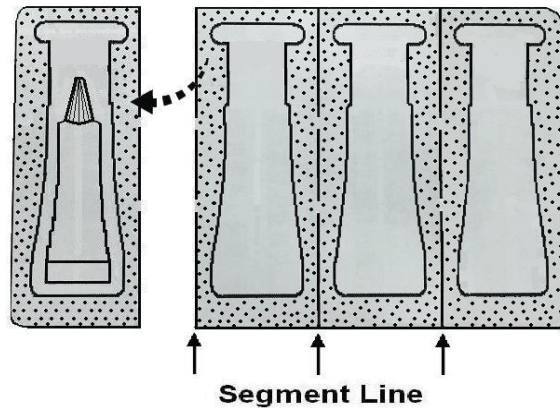

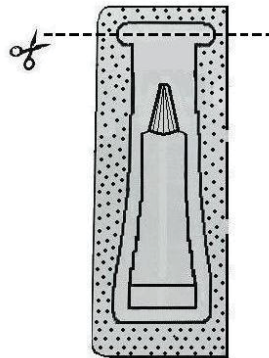


**HOW TO REMOVE AND OPEN THE CHILD RESISTANT PACKAGE**

1. Snap off **ONE** blister pack along the segment line.



2. Use scissors to cut across the top bubble section (Do not harm the tube inside).



3. Peel off the foil from the cut line and take out the tube.

**HOW TO APPLY**

Remember, your cat needs to be dry at the time when this product is applied and must remain dry for 24 hours after application.

1. Hold the tube in an upright position facing away from you and your cat's face and eyes. Screw the cap off the tube.
2. The cat should be standing for easy application. Part the cat's hair and place the tip of the tube through the cat's hair to the skin level at the base of neck and between the shoulders. Squeeze the tube thoroughly to ensure the entire contents are applied in a single spot on the cat's skin.
