The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10. The label submitted with the application has been stamped "Notification" and will be placed in our records.

The following alternate brand names have been removed from the product record:

Per company letter dated April 18, 2019, the ABNs listed above have not been used to market EPA Reg. No. 92413-7.
