The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notice (PRN) 98-10 for the above referenced product. The Registration Division (RD) has conducted a review of this request for its applicability under PRN 98-10 and finds that the action requested falls within the scope of PRN 98-10.

The label submitted with the application has been stamped “Notification” and will be placed in our records.

The alternate brand names Bianova Advanced™ DuraZone® Weed & Grass Killer Concentrate; BioAdvanced™ DuraZone® Weed & Grass Killer Concentrate; BioAdvanced™ Science-Based Solutions DuraZone® Weed & Grass Killer Concentrate; and Fortifend Advanced™ DuraZone® Weed & Grass Killer Concentrate have been added to the product record.
