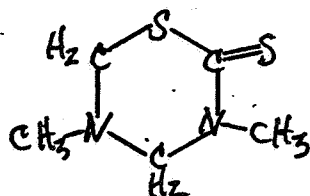

Vinings Chemical Co. is requesting a label change to alter a precautionary statement from "Do not apply in marine or estuarine areas" to read "Do not apply (or use) in estuarine oil fields where drilling fluids (muds) are discharged in the surface water". This change was approved for AMA-35D-P (9386-13), that contains the same active ingredient as in AMA-24.
