Dear Ed:

In response to our telephone conversation of July 10, 1981, regarding the question on the Thimet 20G studies, the following information should prove helpful:

- In Project No. 130-131A in which two field sparrows were found dead, it was concluded that the birds were electricuted because they were found directly beneath the electrified wire, and a crop analysis did not reveal any Thimet 20G granules. It is not uncommon to find dead wild birds directly beneath any type of electrified fence on a farm.

- The transect of each test plot that was walked daily to search for wild bird mortality is diagrammed on the enclosed transect attachment. The establishment of a formalized pathway in search of wild bird mortalities insured uniformity between test plots on a daily basis and throughout the duration of the study.

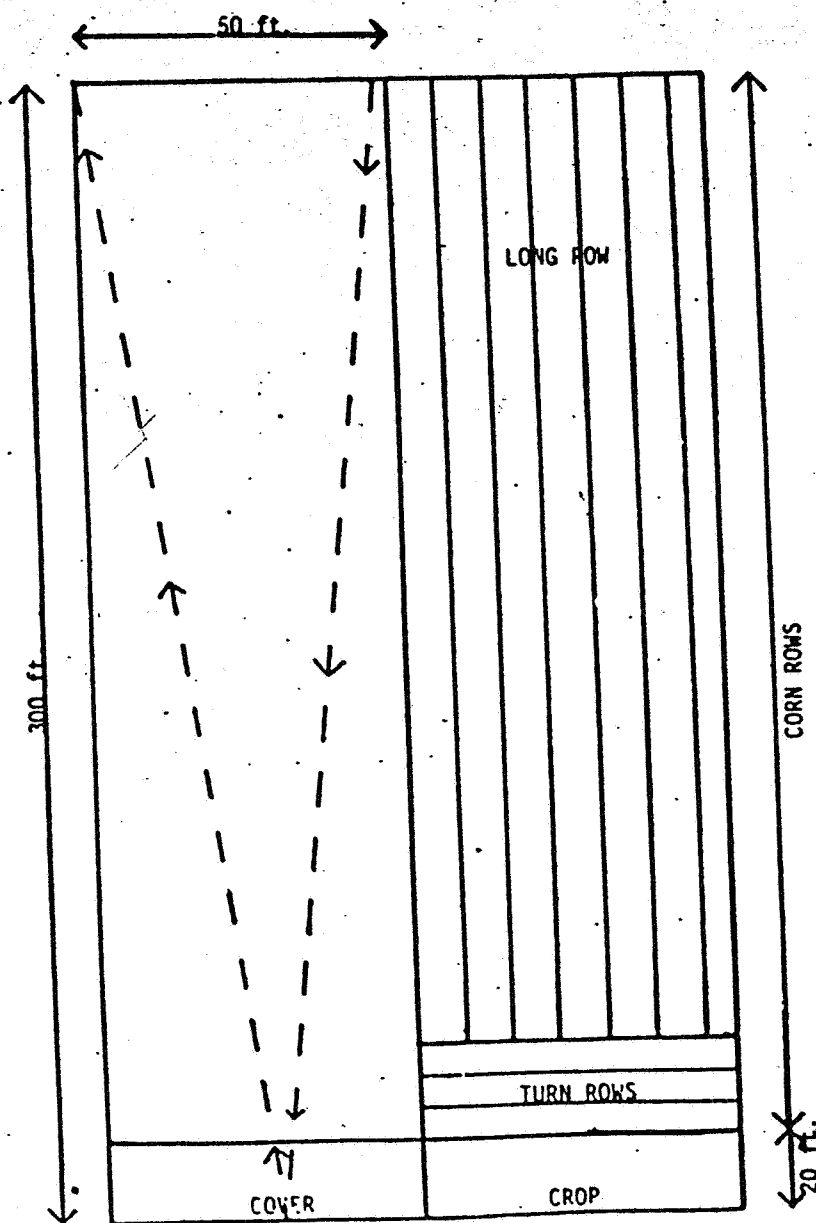
