

Barley and Rye:

25% WP 1 1/2 to 2 lbs./A (0.38 to 0.5 lbs. A/A)

Spray Conc. 1 1/2 to 2 pts./A (0.38 to 0.5 lbs. A/A)

Liquid Conc. 1 1/2 to 2 pts./A (0.38 to 0.5 lbs./A/A)

Do not apply more than once per season.

Do not harvest for food, feed, forage, or graze within 30 days of treatment.

Almonds:

25% WP 1 1/2 to 2 lbs./A (0.38 to 0.5 lbs. A/A)

Spray Conc. 1 1/2 to 2 pts./A (0.38 to 0.5 lbs. A/A)

Liquid Cone. 1 1/2 to 2 pts./A (0.38 to 0.5 lbs. A/A)

Apply in 100 gal. of H₂0 as full coverage spray using not more than 500 gal./A.

Do not apply more than twice per season nor within 60 days of harvest.

Allow 30 days between applications.

ANALYTICAL METHOD

Colorimetric method that measures parent compound and the oxygen analog.
