BACKGROUND:

This amended registration, for the subject disinfecting wipes, was submitted by the registrant, Rickett & Colman Inc.

The registrant, in this amendment, has requested approval to add the

following alternate formulations under this registration: 774-007B, 774-006B, 774-005B and 696-012. Additionally, the label was corrected as requested in the February 21, 2001 Agency letter and a new efficacy label claim was added.

The following documents were submitted and examined in the chemistry review of this submission: registrant's cover letter dated March 15, 2001, application for amended registration dated March 15, 2001, proposed new Alternate Formulations 774-007B, 774-006B, 774-005B and 696-012 dated March 14, 2001, current Basic CSF dated 7/10/89 and current Alternate CSF 656-131 dated March 1, 2000, current product label dated June 17, 1992 and proposed new product label dated 03/15/01.

FINDINGS:

1. The requirements of PR Notice 91-2 were satisfied. The nominal concentration of the active ingredient given in the four(4) Alternate Formulations agreed with the percentage declared on the label.
2. Upper and lower certified limits for both the active and inert ingredients are acceptable.
3. Alternate Formulation 696-012 which utilizes [REDACTED] is not in the inert ingredient database. A full formula disclosure covering this fragrance must be submitted to the Agency for review before this fragrance can be used in this or any other pesticide formulation.
4. All inert ingredients utilized in Alternate Formulations 774-007B, 774-006B and 774-005B are cleared for use in pesticide formulations. These three formulations are accepted.

RECOMMENDATIONS:

This amended registration, for the addition of Alternate Formulations 774-007B, 774-006B and 774-005B under this registration, is accepted.

Alternate Formulation 696-012 is not accepted.

Registrant must request [REDACTED] to provide a complete formula disclosure covering [REDACTED] to the Agency for review.
