IR-4 has submitted a revised Section F in response to the deficiencies noted in our review of 3/3/81 (P.V. Errico, PP#OE2398). We had requested that the petitioner lower the requested tolerance from 0.25 ppm to 0.05 ppm Atrazine in/on guava. We also suggested that Section F be revised to propose the tolerance in terms of Atrazine per se. This has been done.

All deficiencies have been satisfied.

Recommendation

TOX and EFB considerations permitting, we recommend for the requested tolerance of 0.05 ppm atrazine per se in/on guava.
