ISSUES

Aquarium Pharmaceuticals, Inc., the registrant of three enduse products of Simizine did not feel that a DCI issued 9/12/1991 applied to them. The company, therefore, felt that it did not have to respond to the DCI.

RESPONSE

The EEB requirements for the liquid and tablet forms of Algae Destroyer® for aquariums (indoor use) consist of four tests. The requirements for Algae Destroyer for Ponds® (outdoor use) consist of six tests: the same four tests that are necessary for aquarium usage plus two tests with additional species. The six required tests are as follows: 71-1 Avian Oral LD₅₀ (mallard or bobwhite quail); 71-2 Avian Dietary LC₅₀ (mallard and bobwhite quail); 72-1 Freshwater Fish LC₅₀ (bluegill sunfish and rainbow trout); and 72-2 Freshwater Invertebrate LC₅₀ (daphnia). All of these tests should be conducted with the technical grade active ingredient (TGAI).
